NOTIFICATION NO. 492 /

WHEREAS, Hon'ble High Court of Orissa in order dated 17.03.2021 in WP (C) No.6587 of 2021 has directed that Collector, Sundargarh will undertake to visit to the area in the next one week and if he finds that such restriction for only three hours is inadequate, he will issue appropriate orders to further restrict the movement of the vehicles till such time, the enquiry as ordered by the Court hereafter is not completed;

And Whereas Collector, Sundargarh visited the area and interacted with people on 23.03.2021 and also hold a meeting with stakeholders, peoples representatives and villagers at Hemgir on 24.03.2021 for discussion and suggestions on Bankibahal-Taparia road issues;

Therefore, in exercise of powers conferred U/s 115 of Motor Vehicle Act, 1988, I, Nikhil Pavan Kalyan, IAS, District Magistrate & Collector, Sundargarh-cum-Chairman, RTA, Sundargarh do hereby allowed the plying of heavy commercial vehicles, multi-axle vehicles both empty and loaded, which are engaged in carrying coal, iron ore and other materials in **Bankibahal-Taparia road** with the following conditions and restrictions.

1. Time restriction on plying of vehicles from 6.00 am to 1.00 pm except public holidays for school students to safely commute to school from home and vice-versa and public in general.
2. The vehicles shall keep distance of 100 meters between them with 20km speed/hr.
3. Increase the water sprinkling schedule in village area for dust suppression. The Sub-Collector, Sadar, Sundargarh will allocate the stretch of such work among the Companies associated with this road.


4. Strict surveillance at mines to ensure that the vehicles are covered and sealed with Tarpaulin so that no coal dust falls on road.
5. Deployment of watch guards all along the road to control the speed and movement of vehicles. CCTV will be installed in School Compound wall for 24X7 monitoring. The Sub-Collector, Sadar, Sundargarh will allocate the stretch of such work among the Companies associated with this road.
6. RTO and Police will enforce using Interceptor vehicle to check over speeding , overtaking and any other violation .
7. Emergency vehicles such as Ambulance, Fire fighting vehicles shall ply unabated during the restriction period.
8. M/S Jindal Power Limited, Tamnar, Chhattisgarh will start blacktopping road in village area immediately under its CSR programme.
9. The vehicles coming from Rourkela side loaded with Iron ore for Chhattisgarh are to be diverted from Flyover on SH-10 at Sankara By-pass towards Jharsuguda to Chhattisgarh.

Besides the above restrictions ,the following suggestion will also be implemented in a time bound manner .

1. Tahasildar, Hemgir will explore the possibilities of Govt. land for service road in village area and submit report within a week.
2. Tahasildar, Hemgir will also explore the possibilities of Govt. land for Bypass road as discussed in the meeting and submit report within a week.
3. The Compound wall of Schools will be raised using dust and sound absorbent materials.
4. Air Conditioning of Schools is under active consideration.
5. Tahasildar, Hemgir will make field assessment of crop damages due to dust and submit report for consideration of compensation.
6. Renovation and cleaning of affected ponds will be taken up by MCL.


7. Encouraging innocent school students to sit on *Dharana* as well as not discouraging school students who willfully involving in such unlawful activities, are clear violation of Human Rights ^{and} as child rights on the part of parents and guardians.

The order for movement of vehicles with above conditions and restrictions shall come into force with immediate effect till further order.
